Your Privacy is Our Priority.

58Markets Limited ("58Markets Limited") is committed to safeguarding the personal information that you provide us. This Privacy Policy describes how we handle and protect personal information we collect about individuals, such as you, who apply for or receive our services. The provisions of this notice apply to potential, former and current 58Markets Limited Customers.

General Information

At 58Markets Limited, no account or personal information is retrieved from 58Markets Limited's servers when a visitor browses the public (pre-login) areas of our websites. Although 58Markets Limited uses website data to improve the content and services offered to its website visitors, such data is reported on an aggregate, anonymous basis, and we associate no personal information with such gathering of data.
